No. 2023AP1399-OA     Clarke v. Wisconsin Elections Commission

The court having considered the motion of amicus curiae, Matthew Petering, Ph.D., for leave to file proposed remedial legislative district maps and an expert report in support of his proposed maps;

IT IS ORDERED that the motion is denied. The court's December 22, 2023 post-decision order provided that only parties were authorized to submit proposed legislative district maps and that amici were permitted only to file briefs in support of or in opposition to already submitted maps. Consequently, Dr. Petering's proposed remedial maps and expert report submitted on January 12, 2024, are not accepted in this matter, should not be considered by Dr. Grofman and Dr. Cervas, and will not be considered by the court.
